"reduce detrimental effects to surrounding developments areas and to..." 3)Most importantly, LMPOA supports the Beaver Creek Kiwanis, in their request for relief for small, non-profit, events held to raise money. Surely these local fund raisers should not be subject to the same fees as a Rodeo or Carnival.
